COVID-19 NOTICE: All Classic participants, as well as anyone who comes to the event start or finish, must carry proof of their negative COVID-19 test result - taken within 48 hours of arrival in either Wiseman (the day before the start), or Atigun Gorge (the day of the start - Sunday 4/2/23). The test result must be presented upon arrival in order to begin the trek.

The Alaska Mountain Wilderness Ski Classic is an event designed for experienced wilderness athletes and adventurers. The event is difficult and hazardous under the best conditions. Participants are entirely on their own in some of the most remote regions in North America. No help will be available. No rescue can be anticipated. The appropriate knowledge regarding glaciers, avalanches, crossing and paddling major rivers, bear and other animal hazards, illness, injury, gear failure or loss, self-rescue, bad weather, hypothermia, frostbite, extremely difficult terrain, and the like must be acquired before entering the event. All too often, those not experienced in Alaskan wilderness conditions underestimate both the dangers and difficulties to be encountered.

The following legal language has but one purpose. It is designed to relieve everyone involved in the event and its organization from any liability, including any private, government, or Alaska Native entities with ownership or management authority of the land being traversed. Should the worst happen, this prevents the participant and/or the participants next of kin from blaming, suing, or even getting mad at the event organizers, coordinators and other event volunteers. This is a warning. A participant decisions are made on his or her own, and the consequences of those decisions are the sole responsibility of the participant. The participants life is his or her own as well, and if he or she chooses to risk it in the wilderness of Alaska during this event, that decision is entirely up to the participant. Injuries and/or death are not the responsibility of the event organizers.
